ON ABOVE DATE AND TIME I WAS WORKING IN AN [REDACTED] WITH OTHER DEPUTIES IN PLAIN CLOTHES TARGETING KNOWN AND DOCUMENTED UNLAWFUL SEXUAL ACTIVITY IN JOHN PRINCE PARK. THIS IS A PUBLIC PARK LOCATED AT 2520 LAKE WORTH ROAD IN UNINCORPORATED LAKE WORTH, PALM BEACH COUNTY, FLORIDA. AT APPROXIMATELY 3:55 I OBSERVED A DARK BROWN TOYOTA CRUISING THE PARK NEAR THE NATURE TRAILS, SOUTH END OF THE PARK. THIS TECHNIQUE IS KNOWN TO ME FROM PAST EXPERIENCES AS INDIVIDUALS ATTEMPTING TO PICK UP OTHER INDIVIDUALS TO ENGAGE IN ILLEGAL SEXUAL ACTIVITY. THIS VEHICLE WAS BEING OPERATED BY A W/M LATER TO BE IDENTIFIED AS THE DEFENDANT, DAVID A. TORGERSON. THERE WAS NO OTHER PERSONS IN THE VEHICLE. THE DEFENDANT PARKED HIS VEHICLE ACROSS FROM THE NATURE TRAILS AND WALKED IN. I WAS WALKING OUT OF THE NATURE TRAILS, AND THE DEFENDANT LOOKED AT ME AS IF FOR ME TO FOLLOW HIM. I TURNED AROUND BUT I DIDN'T SEE WHERE HE WENT. I THEN WALKED FURTHER INTO THE WOODS ON THE NATURE TRAIL TO FIND HIM. I WAS STANDING NEAR A TRAIL THAT WENT SOUTH OF THE MAIN TRAIL AND SAW THE DEFENDANT WALKING TOWARD ME. I TURNED TO WALK FURTHER BACK INTO THE WOODS AND THE DEFENDANT FOLLOWED ME IN. AS I TURNED AROUND I COULD SEE THE DEFENDANT WAS MASSAGING HIS CROTCH AREA, AND I ALSO COULD SEE THE OUTLINE OF HIS SEMI-ERECT PENIS THROUGH HIS SHORTS. WE WERE NOW OFF THE TRAIL AND STOPPED. THE DEFENDANT WAS GETTING CLOSER TO ME, AND I COULD SEE THE DEFENDANT'S PENIS WAS NOW FULLY ERECT, AT WHICH TIME THE DEFENDANT PULLED HIS FULLY ERECT PENIS OUT THROUGH THE FRONT OF HIS SHORTS AND BEGAN TO MASTURBATE HIS PENIS IN PLAIN VIEW.

AT THIS TIME, I IDENTIFIED MYSELF AS A DEPUTY SHERIFF AND THAT HE WAS UNDER ARREST. THE DEFENDANT WAS CHARGED WITH EXPOSURE OF A SEXUAL ORGAN AND UNNATURAL AND LASCIVIOUS ACTS. HE WAS ISSUED A NOTICE TO APPEAR IN COURT AND RELEASED.
